This can be true if lawyers are involved in a transaction from the start, so that the transaction is appropriately structured and supported by due legal documentation. Therefore legal consultation/guidance at initial stage works as deterrence against a party to back-out from his contractual obligations commitments, representations, etc. or if back-outs, then due legal action before the authority or in the courts of law may be taken.
